

Minutes of the West Norwalk Association  
August 1, 2011

Board Members present were: Joel Zaremby, Galen Wells, Linda Forcellina, Bob Wagman, Chris Potts, Regina Krummel, Ron Paladino, and Anthony Carrano. Gay MacLeod, Ken D'Arinzo, and Bill Krummel were guests.
